



## VOLUNTEER REQUIREMENTS

We are very excited to start working with you but there are some legal and logistical requirements we must address, which vary by role.

**All roles require passing a criminal background check  
and agreeing to & signing our Volunteer Agreement form.  
Must be able to provide supporting documentation for all requirements.**

### **First Aid Instructor Requirements (Excluding Stop the Bleed)**

1. Current certification from one of the below:
  - a. Healthcare Professional (as defined [here](#) or as listed below) **OR**
  - b. Adult 1st Aid/CPR/AED (or higher) from the Red Cross, American Heart Association (AHA), or American Health & Safety Institute (ASHI) / Health & Safety Institute (HSI)
2. Current Instructor Certification for Adult 1st Aid/CPR/AED (or higher) from the Red Cross, AHA, or ASHI / HSI
3. First Aid/CPR Instructor Liability Insurance

### **Stop the Bleed Instructor Requirements (Excluding 1st Aid/CPR/AED)**

1. Fulfill either 'a' or 'b' below:
  - a. Healthcare Professional (as defined [here](#) or as listed below) **OR**
  - b. NON-Healthcare Professional **AND** both of the below:
    - i. Certified in Adult 1st Aid/CPR/AED (or higher) from the Red Cross, AHA, or ASHI / HSI
    - ii. Current Instructor Certification for Adult 1st Aid/CPR/AED (or higher) from the Red Cross, AHA, or ASHI / HSI
2. Stop the Bleed training certificate from within the last year
3. First Aid/CPR Instructor Liability Insurance

  - b. USCCA Instructor
    - i. Concealed Carry and Home Defense Fundamentals (CCHDF)
    - ii. Defensive Shooting Fundamentals
2. Firearms Instructor Liability Insurance

## Gun Store & Range Buddy Requirements

1. Fulfill either 'a' or 'b' below:
  - a. Meet the requirements to be a Firearms Instructor
  - b. Current Concealed Carry Permit from Virginia (CHP), Maryland (W&C), or the District of Columbia (CCPL) and a training certificate (of some kind) from within the last 3 years
